- Buses can drop off students at the P-5 lot you see located on the map. (P-5 is closest to the John A. Danzi Athletic Building where students will wait for their scheduled competition time.)
- Advisers should check in at the entrance of the John A. Danzi Athletic Center once you and your students have arrived at the campus. There will be a registration table located right at the entrance. A continental breakfast will be available for students and teachers in the Danzi gym as well.
- The students will wait in the gym for their scheduled competition time and should be aware of the time. They should head to the lobby 15 minutes before their scheduled competition time and they will be escorted to the competition area 10 minutes before their scheduled time begins. Most categories will be competing in the McGann Conference Center, in O'Connor Hall, with the interviews being held in the John A. Danzi building (athletic building).

- There will be an opening ceremony in the gym at 8:20 a.m.
- While students wait for their competition time, they have the opportunity to attend two workshops held in the Danzi Athletic Center: "Be Engaging: Thinking Entrepreneurially in a Digital World" from 10-10:30 a.m. and a Career Preparation and Professional Development workshop from 9:30-11 a.m.
- Campus tours are available and will start in the lobby of the Danzi building. Please let students know that they are encouraged to tour the campus, but must stay with their tour leader.
- The competition will run from 8:30 a.m. until about 11:15 a.m.
- Lunch will be served about 11:30 a.m. in the Danzi building.
- The awards ceremony will begin at noon in the auditorium in O'Connor Hall. The ceremony will be finished by 1 p.m., so you can leave promptly to return to your schools.
